Mercantile Rules

- ★ **Setup** starts at 2pm Friday. 8am on Saturday and Sunday. — Tear-down starts 8pm Friday & Saturday. 4pm on Sunday
- ★ Vendor shall not sell any goods or services other than those described herein at or during the event.
- ★ Vendor’s station shall fit in the allotted size; shall be clean and orderly; and must comply with all applicable laws and regulations.
- ★ Vendor will be required to have proper anchors/weights for their tents.
- ★ Cars/Trucks can be driven to your space for setup and teardown **ONLY** during those hours.
- ★ All vehicles **MUST** be moved to general parking immediately after completely setup & teardown
- ★ There will **NOT** be security or policing of the area during or after hours.
- ★ No loud music or amplified devices allowed.
- ★ The Zimmerman Civic Club reserves the right to **CLOSE & EVICT** any Vendor/Stand that does not follow the rules and/or is deemed inappropriate for the Mercantile by a Civic Club Member.
- ★ All items not sold and or debris remaining from the Vendor stands **MUST BE** removed before vendor leaves.
- ★ All Vendors agree to be courteous to the grounds, guests, & other Vendors.
- ★ Vendors that close or leave early **WILL NOT** be invited back next year.
